by a power roller. The asphalt at the concrete transitions will be milled prior to paving for

Option 1 - To excavate the area in green (approximately 900 sq. yds.) back to the original	
rock base and haul the excavated material from the job site. To grade the base and layer	
in with 3-4" of base mix asphalt - add \$27,000.00.	
Option 2 - To mill the entire lot and haul the milled material from the job site. To grade	
the existing base and pave the entire lot with 3" of compacted BP-1 grade asphalt	
installed in the same manner as above - \$176,322.00

- 1. If contract is under unit price, payment shall be determined upon completion of work on actual quantities of work performed.
- Any area, before being turned over to us for paving, should be firm and unyielding and under no circumstances shall we be responsible for the condition of the sub-base below the grade at which our portion of the work begins or for any defects or failures in our work due to the condition of the sub base.
- 3. Where Gevers Paving Co., Inc. agrees to do fine grading, said fine grading will be work which can normally be done with a motor grader. It will not require the addition or removal of any material.
- 4. Any alteration or deviation from the specifications of this contract and any extra work shall be set forth in writing and signed by both parties.
- 5. All proposals or contracts are subject to delays caused by strikes, accidents, weather conditions, inability to obtain labor or materials, or any other cause beyond our control, and any unavoidable delay on the part of Gevers Paving Co., Inc. shall not operate as a forfeiture of this contract.
- 6. There shall be no liability on the part of Gevers Paving Co., Inc for damages resulting to utilities or other facilities or objects buried beneath the area of construction.
- 7. Gevers Paving Co., Inc is covered by Workmen's Compensation Insurance covering its employees, Public Liability and Property Damage Insurance.
- 8. This proposal is valid for a period of 30 days from the date shown hereon. This period may be extended at the sole option of Gevers Paving Co., Inc.
- 9. Gevers Paving Co., Inc. cannot guarantee that all water will drain from areas with 2% or less slope for pavement, some ponding may occur.
